

## Low Income Weatherization Program

Dear McMinnville Water & Light (MW&L) Customer:

Thank you for your interest in making your home more energy efficient. Below you will find a list of conservation measures in our Low Income Weatherization Program. To qualify for our program your home must be electrically heated and you must meet the income guidelines (page 2 of packet).

**Insulation:** Signs of an under-insulated home include: cold floors, drafty and cool walls in the winter, as well as hot ceilings in the summer. **Current rebate is dollar for dollar of project cost.**

**Windows:** MW&L offers dollar for dollar (not to exceed \$20. Sq. Ft.), to replace existing single pane windows, single pane with storms, or double pane metal. New windows must have a u-value of 0.30 or lower (0.35 for patio doors), and must be installed in a heated space.

**Duct Sealing:** Duct systems are notoriously leaky, dumping the hot/cold air under your home or in your attic, instead of in your living space. **The available rebate is dollar for dollar, not to exceed \$500.**


**Ductless Heat Pumps:** Want a heat pump and A/C without the duct work? **MW&L is offering up to \$3800.** for homes with existing zonal heat (permanently installed baseboard, ceiling or wall heat or a forced air electric furnace).

**Ducted Heat Pumps:** Many things effect how efficiently your new ducted heat pump will work, an important one is to have it installed and tested to MW&L "PTCS" specifications, which **will qualify for a rebate up to \$3800.**

**Heat Pump Water Heaters:** Cut your heating bill by 50%, **up to \$1360. Rebate for Tier 1 and up to \$1700. For Tier 2.**

**MW&L requires pre-approval for all conservation projects.** We look forward to helping you save energy and lower your electric bill. Please call 503-435-3115 if you need more information, or if you have any energy related questions.
